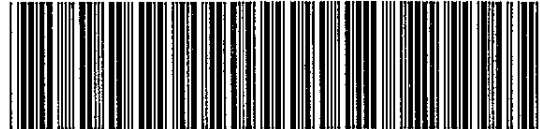




**FIRST:** The following Article I is hereby amended to read as follows:


**ARTICLE I - NAME**
