**ARTICLES OF DISSOLUTION

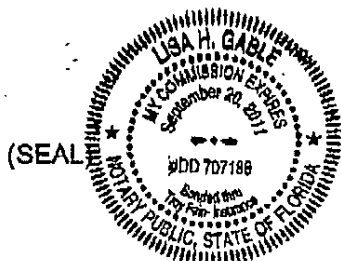
