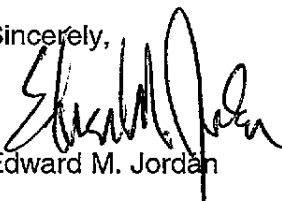
Re: Resignation of Registered Agent
