This was the first time I had become aware that

there was any problem.

I would request that you please consider the circumstances regarding this event, as follows:

I am currently in the process of finalizing a divorce that has been continuing for the past two years.

My now (ex wife) during this period, has been stealing my mail, including checks which are in payment for the services my corporation provides.

She has been able to gain access to my post office box (9525 Coral Springs 33075)

In 1996, when the division sent back my annual report for a problem with the signature, I was never aware that this had occurred, as she had no doubt destroyed your letter, in an attempt to hurt me, in any way that she could.

As you are no doubt aware, I made every attempt to file my annual reports for the years 1996 and 1997, and would surely have responded in 1996 had I known that there was a problem.
