This letter is in response to your notice date May 23, 1997. We are enclosing a signed annual report (by both the registered agent and an officer of the corporation), a copy of your notice, and a check for \$495. This check represents the \$61.25 filing fee per year for the years 1995 thru 1997 and the \$103.75 corporate supplemental fee per year for the years 1995 thru 1997.

Per discussion with your office of this date, we are requesting that the \$585 reinstatement fee be waived. First Hoontrakul Corporation never did receive their annual reports for the years in question. The principals of this corporation are foreigners and they rely on their professionals in Florida to be sure that all the proper filings are timely and up to date. This corporation did have several address changes in the prior years, but we were with the understanding that the attorney who was handling the account during this time had notified the Florida Department of State of the new address changes. It was not until we, as the current registered agent, attempted to file the current report that it was discovered that this has been delinquent since 1995.
