This letter is to alert you of a recent fraudulent activity found in my documents.

On Saturday, January 10, 2015 u sent the email notification that the 2015 Annual Report for my business was due for filling.

Upon signing up to the website I learned that the report for 2015 had already been filed. Been a one-man office I found it strange since there are no other individual in my business, other than me, to complete the application and found that someone had amended the entire document without my knowledge or my consent.

It is my responsibility to alert you that an individual w the name : Savage, Christopher K at 8307 NE Miami Ct., Miami FL 33138 had fraudulently amended my information. Am including a copy of what I had printed off the website for your use.

Upon learning of this situation, I immediately called the Division of Corporations and successfully updated all my information as true and legal for Tropolis, Inc.

I have also approached the Miami Police Department and filled a report on this issue w Case No. 150114-013703 by the Officer J. Guerrero since this morning I learned that this individual also attempted to obtain debit cards from my Tropolis checking account w Bank Of America.

I approach you w the concern, that anyone can actually make these changes with no proper identification; **that no alerts or notifications were provided after changes have been completed** and implore you to look into ways to improve your system to minimize or avoid completely this type of fraud from occurring.

Will also appreciate if you can alert me if there is anything else I shall do in order finalize this problem, ways to avoid it from happening again and/or help w prosecuting this individual. I can be reached at (305) 531-3131.
