The U.S. Department of the Treasury's Office of Foreign Assets Control ("OFAC") administers a comprehensive economic sanctions program that targets the property and interests in property of any person designated pursuant to the authority of Executive Order 12978 of October 21, 1995 (the "Order"), the Narcotics Trafficking Sanctions Regulations, 31 C.F.R., part 536 (the "Regulations"), and the International Emergency Economic Powers Act, 50 U.S.C. 1701 et seq.

OFAC has the authority to name individuals and entities as Specially Designated Narcotics Traffickers ("SDNTs") pursuant to the Order and the Regulations. Property and interests in property of an SDNT that are within the United States or within possession or control of any U.S. person are, with limited exceptions, blocked. Also, any transaction or dealing by a U.S. person, or within the United States, in property or interests in property of an SDNT is prohibited. A U.S. person may not, except as authorized by OFAC, provide services to or engage in any financial transactions with an SDNT.
