AMENDMENT TO  
ARTICLES OF INCORPORATION

Leavitt Management Group, Inc., a Florida corporation (the "Corporation"), through the action of all of its shareholders and members of its Board of Directors hereby amends its Articles of Incorporation for the purposes set forth below in accordance with the Florida Statutes.

1. The Corporation hereby duly adopts the following amendment to its Articles of Incorporation:

- A. Article III shall be replaced in its entirety with the following:

ARTICLE IIIShares

The aggregate number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is Twenty Million (20,000,000) shares of common stock having a par value of \$.001 per share. The Board of Directors of this corporation shall have the power to divide and issue the common stock into one or more series and to determine the limitation and relative rights of each such series, consistent with the laws of the State of Florida. Shares of one series may be issued as a share dividend in respect of shares of another series."

2. All of the provisions of the Articles of Incorporation not amended herein are hereby ratified, confirmed and shall remain unchanged.

3. Pursuant to that certain Written Consent in Lieu of a Meeting of the Board of Directors and Shareholders of the Corporation, dated as of June 30, 1999, the foregoing amendment was adopted by all of the shareholders of the Corporation and all of the members of the Board of Directors of the Corporation which constitute a sufficient number of votes for approval of the amendment, effective as of June 30, 1999.

IN WITNESS WHEREOF, the undersigned President of the Corporation has executed these Articles of Amendment to the Articles of Incorporation as of this 30th day of June, 1999.
