Previously, the above referred to corporation was administratively dissolved on September 21, 2001 for failing to file its annual report.

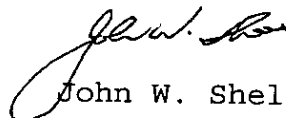
For your information, our offices never received the annual report for the corporation for 2001 and it was only recently discovered that the corporation was dissolved administratively. When talking to the Division of Corporation concerning JOIMO's dissolution administratively, I was informed by them that their records showed that both the first and second notices were returned to Florida, apparently because they were undeliverable, even though in prior years, the address utilized, 340 Royal Poinciana Plaza, Palm Beach, Florida got such annual reports to me and we were able to file them timely and pay the necessary fees to keep the corporation in existence. Therefore, it is respectfully requested that the reinstatement fee of \$600.00 be waived.

Toward the end of getting JOIMO, INC. reinstated, I am enclosing the Corporation Reinstatement form, which has been duly completed and executed by one of the officers of the corporation and Mettler, Shelton and Randolph check number 001489 made payable to Department of State in the amount of \$458.75 in order to pay the annual fees of \$150.00 for years 2001, 2002 and 2003 and also to pay for a certificate of status in the amount of \$8.75.

If you could waive the reinstatement fee based on the above and in due course send to me a certificate indicating that JOIMO, INC. is reinstated and in good standing, it would be appreciated.
