## AMTRADE INTERNATIONAL BANK OF FLORIDA INTO AND WITH AMTRADE INTERNATIONAL BANK OF GEORGIA

AMTRADE INTERNATIONAL BANK OF GEORGIA, a Georgia state-chartered bank, and AMTRADE INTERNATIONAL BANK OF FLORIDA, an agreement corporation organized under the laws of Florida, hereby adopt the following Plan of Merger pursuant to Georgia Code Section 7-1-531:

- 1. The names of the corporations proposing to merge are AMTRADE INTERNATIONAL BANK OF GEORGIA ("AMTRADE Georgia") and AMTRADE INTERNATIONAL BANK OF FLORIDA ("AMTRADE Florida"), its wholly owned subsidiary. AMTRADE Georgia is the parent corporation and shall be the surviving corporation.
- 2. The name of the resulting bank shall be: **AMTRADE INTERNATIONAL BANK OF GEORGIA** (the "Surviving Bank").
