Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendments to its Articles of Incorporation.

FIRST: The Corporation hereby deletes Article III of the Articles of Incorporation in its entirety and replaces it with the following Article III:

“ARTICLE III

Section 1. The maximum number of stock that this corporation is authorized to have outstanding at any time is 100 shares of Five (\$5.00) par value common stock, divided into two classes, the designation and par values of each such class being as follows:

- A) 1 share of Class A Common Voting Capital Stock, having \$5.00 par value; and
- B) 99 shares of Class B Common, Non-Voting Capital Stock, having \$5.00 par value.

Section 2. All of said shares of both classes shall have equal preferences, limitations and relative rights, except that the Class B Non-Voting Capital Stock shall have no voting rights whatsoever, either individually or as a class.”
