I recently received to notice that my corporation has been dissolved for lack of paying my corporate annual fee of \$150.00. I was sure this had been paid and mailed but can find neither the canceled check nor the un-mailed form.

At the time of renewal, we had just found out my father had been diagnosed with terminal cancer. After months of treatments and surgeries, He died on March 9, 2000 (a copy of the death certificate is attached). Since I am the only child that lives locally I have spent the last nine months taking care of my father, mother and all the family matters connected with illness and death of a relative.

I am asking for leniency from the state that due to extenuating circumstances and ask that you reinstate my corporation and wave the penalties and late fee of \$400.00. I have been a small Florida Corporation (V42320) since June 6, 1992 and have never been late with my corporate renewal before.

Please give this matter your careful consideration and notify me of your decision. Attached is a copy of the notification of corporate dissolve and also a check for \$150.00 in hopes that you grant my request.
