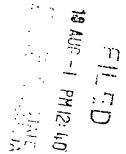

Pioneer Bankcorp, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in accordance with the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), does hereby amend its Articles of Incorporation, as amended ("Articles") by filing these Articles of Amendment and, in connection therewith,

HEREBY CERTIFIES:

That the name of the Corporation is Pioneer Bankcorp, Inc.

Pursuant to the provisions of the Act, Article IV, of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and inserting the following in lieu thereof:

ARTICLE IV

Capital Stock

Α. Number and Class of Shares Authorized: Par Value

The aggregate number of shares which the Corporation shall have authority to issue is 10,000.000 shares of common stock having a par value of \$0.01 per share, which shall be designated "Common Stock."
