As per my telephone conversation on 7-15-98 with your employee "Robin", enclosed please find my check with current date in the amount of \$150.00 as instructed.

As I explained to Robin, I have two Florida Corporations "Debsco Investments Inc." as above referenced and Hanson Murphy Inc. (Corporate # 65-0414958).
