With respect to the above captioned subject, please be advised that I did not receive the original renewal document V45097 in due time and as a result, I requested a new document which was received in June 2001. This document was completed and returned to your department on June 26, 2001, attached to which was also the sum of \$158.75 as the renewal fee.

Your department replied several weeks after, stating that the corporation in question was administratively dissolved because of the late arrival of the renewal document. Prompted by your action taken, I immediately contacted your department explaining my position. I was advised by the officer to remit the sum of \$391.25 to your department with the returned document. Your department recently returned the document and check for the same reason of lateness.
