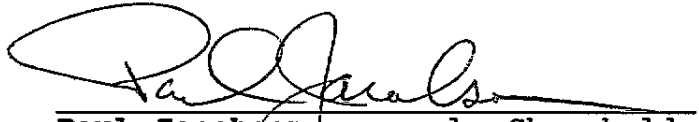
## ARTICLE V: VOTING BY GROUPS

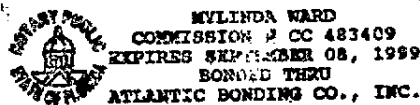
