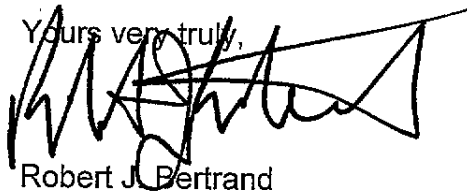

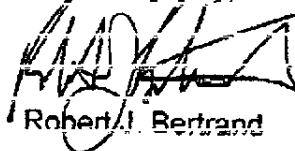

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, ENDODONTIC ASSOCIATES OF GAINESVILLE, P.A., a Florida professional service corporation (Document Number V48791), pursuant to a resolution duly adopted by the joint written consent of its sole Shareholder and its sole Director on April 29, 2002, hereby adopts the following Restated Articles of Incorporation:

**ARTICLE I - NAME**

July 2, 1992 effective as of July 1, 1992, and any amendments thereto.

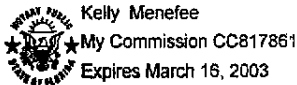

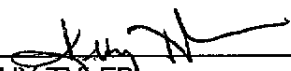
