ARTICLES OF AMENDMENT
OF THE
ARTICLES OF INCORPORATION
OF
IMAGE GRAPHIC~~S~~ SYSTEMS, INC.

IMAGE GRAPHIC~~S~~ SYSTEMS, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation, in accordance with the requirements of Chapter 607, Florida Statutes, hereby certifies as follows:

1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on July 10, 1992, at which time the name of the Corporation was IMAGE GRAPHIC~~S~~ SYSTEMS, INC.

2. The Amendment to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article I of the Articles of Incorporation as of the date hereof, and by substituting in its place the Article set forth below.

3. As amended below, Article I of the Articles of Incorporation has the sole effect of changing the Corporation's name from "Image Graphic~~S~~ Systems, Inc." to "IGS Technologies, Inc." The Amendment to the existing Articles of Incorporation being effected hereby will make no change in the current capital structure of the Corporation.

4. This Amendment to the Articles of Incorporation was approved by a unanimous Written Consent of the Board of Directors of the Corporation, adopted on the 3 day of ~~January~~ ^{JULY 2000}, 1999, ~~1999~~ and by a unanimous Written Consent of the Stockholders of the Corporation, adopted on the 3 day of ~~January~~ ^{JULY 2000}, 1999.

5. The Amended Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, and thereafter the name of the Corporation shall be "IGS Technologies, Inc." and Article I of the Articles of Incorporation of the Corporation shall read as follows:

Article I - Name

The name of the Corporation shall be: IGS TECHNOLOGIES, INC.



