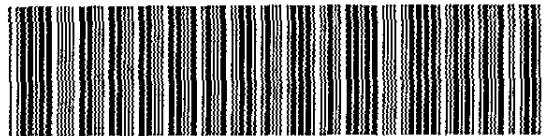


Bakomoorf, Inc., a Florida corporation, intending to be dissolved pursuant to Florida Statute, § 607.1403, hereby sets forth the following required information:
