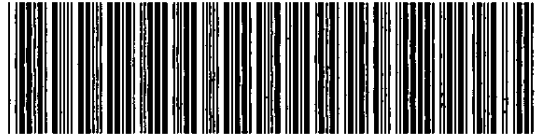



Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment:

1. Article IV of the Articles of Incorporation shall be deleted and replaced with the following new Article IV:

“ARTICLE IV - STATED CAPITAL


The corporation is authorized the issue the following capital stock:

<u>No. Shares</u>	<u>Classification</u>	<u>Par Value</u>
2000	Class A - Voting Common	\$.05
8000	Class B - NonVoting Common	\$.05

Each share of outstanding and issued Common stock shall be exchanged for 20 shares of newly issued Class A - Voting Common stock and 80 shares of Class B - Non-Voting Common stock.”

2. These Articles of Amendment to the Articles of Incorporation shall be effective upon thier filing with Florida’s Department of State.

3. These Articles of Amendment were approved by the Shareholder(s). The number of votes cast for the Articles of Amendment by the Shareholder(s) were sufficient for approval. on July 20, 2008.
