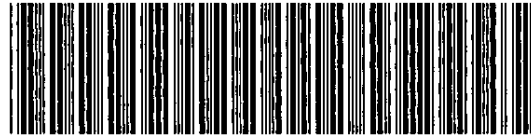



1. I am the President of the corporation formerly named Flagler Lawn Spraying, Inc.
2. Flagler Lawn Spraying, Inc. became the owner of the trademark "Sun Country Pest Control".
3. On or about April 6, 2012, Articles of Amendment to the Articles of Incorporation of Flagler Lawn Spraying, Inc. were filed with the Division of Corporation to change the name of the corporation.

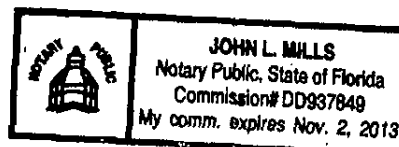
