RISCORP OF FLORIDA, INC., a Florida corporation organized and existing under the laws of the State of Florida ("the Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on the 14th day of July, 1992, and amended on 26th day of August, 1993.
2. The amendment to the existing Articles of Incorporation as amended on the 26th day of August, 1993 being effected hereby is a change in the name of the Corporation from "RISCORP OF FLORIDA, INC." to "GREENSTREET OF FLORIDA, INC."
3. These Articles of Amendment were approved by written action of the sole director as proposed by the majority of stockholders of the Corporation entitled to vote thereon, on the 28th day of May, 2003. The number of votes was sufficient for approval.
4. After payment of all required fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time existing Article I of the Articles of Incorporation as amended of the Corporation shall be deleted in its entirety and the following Article I shall be substituted in its place:

ARTICLE I -- NAME

The name of this Corporation shall be:

GREENSTREET OF FLORIDA, INC.

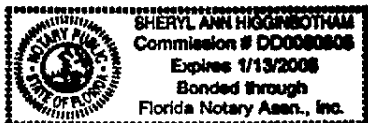
