

Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation does hereby adopt the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Gammill Transportation, Inc. (Document Number V51274).
2. Article I of the Articles of Incorporation of the corporation shall be amended in its entirety to read as follows:

"ARTICLE I – NAME

The name of this Corporation is TRY ENTERPRISES, INC."

3. 
