ARTICLE I. "NAME" is amended to read as follows:


The name of the corporation is "**MANCUSO VENTURES, INC.**" and the address is 203 Miramar Drive, Lakeland, Florida 33803.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

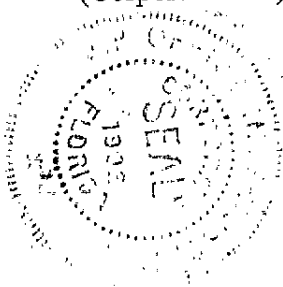
