The **\$375.00 is more than 2/3's of my husband's weekly salary!** Not only was this the **ONLY** notice we had gotten this year about the Annual Report, it was actually sandwiched in all the junk mail/newspapers that arrive in our mail box on a daily basis. Fortunately, I looked through all the mail and the report form fell out of the center of a U-Save coupon newspaper. I almost threw it out thinking it was part of the junk mail I was leafing through! Upon checking our records, you will notice that we are always diligent with our payments. Under the circumstances I would ask that you dismiss all penalty charges. I plan on putting some sort of "tickler" on my 1998 calendar to ensure that if I do not receive the Annual Report Form by a certain date that I will call the Dept. of State and ask why.

After receiving this form, I began calling the Dept. of State. The lines were constantly busy and then I was told by an Operator that there had been a lightning strike and all computers and phone lines were down. I called today and spoke with a representative who instructed me to send a company check for \$165.00 along with the current form and an explanation (above) as to why the penalty should be waived.
