## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF HEARNE GRAZIANO & NADER, P.A.



HEARNE GRAZIANO & NADER, P.A., a corporation organized and existing under the laws of State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:
