ARTICLES OF DISSOLUTION

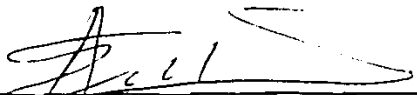
Article 1: The name of the corporation is Yatayans, Inc.

have been paid.

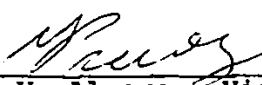
Article 3: All assets, including real, personal and mixed property,

corporation adopted this August 19, 1997.



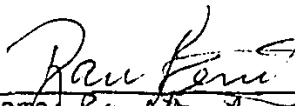

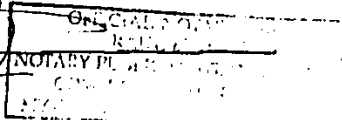
