Dear Sir or Madam:

Our corporation has been cancelled. Let me take a few minutes of your time to explain the events that have led to this. In September of 1996 we moved from 3123 W 72nd Terrace, Hialeah FL / P O Box 2966 Hialeah, FL to 15398 Tangerine Blvd, Loxahatchee, FL. I went ahead and obtained a new occupational license and a new Sales Tax number (see attached copies of same) as we are now in a different county. I thought that informing the Department of Revenue of the new address would also change the information in your records.

Our Corporation renewal for 1997 must have been mailed to our old address and we never received it. I understand that your office does this as a courtesy and that it is my obligation to make sure I file my corporate documents on time. When filing the corporate documents for the company I work for on a full time basis, I realized that I had not received the documents for Graphics Unlimited. I called and was informed the corporation had been dissolved.

Graphics Unlimited is a home based part time graphic design company my husband and I run for additional spending money. We barely make \$1000 a year to cover the \$900 to re-instate the company. We filed corporate income tax returns for the company for '97, and have been paying sales taxes in 97-98. Please take into account these events and accept the enclosed \$315 to pay for the 1997 and 1998 corporate renewal fee and reactivate the corporation.

Your understanding with our dilemma will be greatly appreciated.
