# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF COVENTRY INDUSTRIES CORP.

### (Document No. V58119)

The undersigned, Robert L. Hausman, President of Coventry Industries Corp., a Florida corporation organized and existing under and by virtue of the Florida Business Corporation Act (the "Corporation"), does hereby certify:

- The name of the Corporation is Coventry Industries Corp.
- 2. The following provisions of the Articles of Incorporation of the Corporation are amended in the following particulars:
  - Article I is deleted and replaced with the following:

#### "ARTICLE I CORPORATE NAME

The name of this Corporation shall be American Risk Management Group, Inc.

Article IV is deleted and replaced with the following:

### "ARTICLE IV CAPITAL STOCK

The maximum number of shares that this Corporation shall be authorized to issue and have outstanding at any one time shall be fifty five million (55,000,000) shares which are to be divided into two classes as follows:

55,000,000 shares of common stock with a par value of \$.001 per share; and

5,000,000 shares of preferred stock, with a par value of \$.001 per share.

Series of preferred stock may be created and issued from time to time, with such designations, preferences, conversion rights, cumulative, relative, participating, optional or other rights, including voting right, qualifications, limitations or restrictions thereof as shall be stated and expressed in the resolution or resolutions providing for the creation and issuance of such series of preferred stock as adopted by the Board of Directors pursuant to the authority in this paragraph given."
