

Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is ABRAHAM/MIAMI, INC.
- 2. The following Amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 10^{7} day of frame, 1998, in the manner prescribed by Florida law.
