ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
TRADE CENTER IMPORTS, INC.

1. Pursuant to Florida Statute 607.1006, TRADE CENTER IMPORTS, INC. hereby adopts the following Articles of Amendment to its Articles of Incorporation:

A. The name of the corporation is hereby changed to STRUCTURESHIELD SYSTEMS, INC.

B. Article III is amended to provide that the aggregate number of shares of stock that the corporation is authorized to have outstanding at any one time is 150,000 shares at \$1.00 per share par value, consisting of a single class and series.

2. The Amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

3. The Amendment was adopted on the 1 day of March, 1998.

4. The Amendment was approved by a vote of shareholders sufficient for approval in accordance with the corporation's Articles of Incorporation and Bylaws. Only one voting group was entitled to vote on the Amendment.


