To Whom It May Concern:

My name is Jose F. Chavarria, Jr. and recently my Brother (Edwin Lopez) and I were trying to change the officer's of my fathers' (Jose F. Chavarria Sr.) corporation (Frank's Car Repair.) We were informed that sometime last year there was a bounced company check and the corporation was diminished. It was also brought to my attention that the Florida Dept. of State sent a letter prior to diminishing the corporation explaining what was going on. At that time I was not here in Miami and he was probably not aware of the situation due to his sickness. We are trying to get the corporation (Frank's Car Repair) up to date due to the fact that my father (Jose F. Chavarria) passed away on March 26, 2001. My father was battling with cancer since September of 1999. He periodically started to worsen in health. I had to be discharged from the United States Army due to my fathers' sickness. With my fathers' death we need to continue the business in order to pay for our housing and living costs. As well we do not have the \$900.00 dollars that are being asked of us in order to reestablish the corporation (Frank's Car Repair.) I spoke with a representative on the phone and they advised me to write this letter explaining the situation, plus to include a money order for \$150.00, of why the Annual Report for the year 2000 was not paid. Enclosed as well you will find another money order, which I had sent prior to this letter, in the amount of \$158.00 which was for the cost of changing officers in corporation. Attached will also be a copy of my fathers' death certificate. If you could please advise me of what further options I might have in order to reinstate the corporation I would really appreciate it.
