ARTICLES OF DISSOLUTION
OF

Pursuant to Section 607.1403, Florida Statutes (1995), CORONAVEST, INC., a Florida corporation having its principal office in Jacksonville, Florida (hereinafter called the "Corporation"), hereby certifies as follows:

FIRST: The name of the Corporation is CORONAVEST, INC., a Florida corporation.

SECOND: All of the shareholders of the Corporation, acting pursuant to Sections 607.0704 and 607.1402, Florida Statutes (1995), have voted in favor of a resolution authorizing dissolution of the Corporation, and the number of shareholder votes cast for dissolution was sufficient for approval. Voting by voting groups was not required. All shareholders of the Corporation have executed a written consent dated as of February 28, 1997 authorizing the dissolution of the Corporation in the manner provided by the Florida Business Corporation Act.

THIRD: Dissolution of the Corporation shall become effective at midnight on December 15, 1997.
