**ARTICLES OF AMENDMENT OF  
THE ARTICLES OF INCORPORATION OF  
WEISER CTTT OF GEORGIA, INC.**

Pursuant to the provisions of Section 601.1006 of the Florida Business Corporation Act, **WEISER CTTT OF GEORGIA, INC.**, a Florida corporation (the "Corporation"), adopts the following articles of amendment to its Articles of Incorporation.

**ARTICLE I**

The name of the Corporation is Weiser CTTT of Georgia, Inc.

**ARTICLE II**

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:
