RESTATED ARTICLES OF INCORPORATION OF THE EMPLOYERS SAFETY GROUP ASSOCIATION, INC.

n Act, the

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned corporation pursuant to a Resolution adopted by its Board of Directors, hereby adopts the following Restated Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION

The name of this corporation shall be Employers Safety Group Association, Inc. with a corporate address of 2310 A-Z Park Rd., Lakeland, Florida 33801.

ARTICLE II: DURATION

The existence of the corporation is to be perpetual unless dissolved according to law.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is to engage in any activity on business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV: CORPORATE STOCK

The number of shares of stock that this corporation shall have the authority to issue is 500 shares at a par value of \$1.00.

ARTICLE V: REGISTERED OFFICE AND REGISTERED AGENT

The registered office of the corporation shall be 2310 A-Z Park Rd., Lakeland, Florida 33801, and the registered agent at that address shall be William B. Bull.

ARTICLE VI: NUMBER OF DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three persons or more than nine persons.

ARTICLE VII: NOMINATION AND ELECTION OF DIRECTORS AND OFFICERS

Directors shall serve terms as specified in the Bylaws and may be nominated and elected for subsequent terms.

ARTICLE VIII: INDEMNIFICATION OF DIRECTORS AND OFFICERS

This corporation shall indemnify any officer or director, or any former officer or director to the full extent permitted by law.

ARTICLE IX: BYLAWS

The Bylaws of the Corporation shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

The foregoing Restated Articles of Incorporation restate and integrate the Articles of Incorporation and Amendments heretofore filed and also amends Article V and Article VII of the original Articles. Except as to these Amendments there is no discrepancy between the existing provisions and the provisions of these Restated Articles of Incorporation.

RESOLVED, that the Articles of Incorporation of the Employers Safety Group Association, Inc., shall be restated in the form of Exhibit A attached hereto to include therein an amendment to the original Articles changing from 100 to 500 the number of shares of stock that the corporation shall have the authority to issue.
