On April 30 1997 I sent to your department two checks along with renewal applications for two corporations: American Equity Capital Inc. and Limbsaver, Inc. On 13 June the check for renewal of AEC was negotiated by NationsBank with renewal of the corporation shown by the Certificate of Status we received. No action was reported by you at that time on the Limbsaver application. I assumed that there was some technical reason for you to delay action and that we would shortly be hearing from you were there a problem.

Although I noted occasionally that NationsBank check #2588 was still open in my checkbook, other events, incorrectly, put me off pursuing this anomaly.

Today notice was received that the corporation had been dissolved. I called your office to pursue this question. The respondent said that a notice of impending dissolution had been sent to this address in June. Neither the president nor I received this notice. The gentleman with whom I spoke a short time ago said that it had been returned to you (I think he said) as undeliverable.

Pursuant to his directions, we are returning the Application for Reinstatement with a new check for \$173.75 in order to continue the viability of Limbsaver, Inc. I also have stopped payment on the check mailed to you in April. I regret these series of events placed Limbsaver, Inc. in jeopardy, and appreciate the helpful comments of the corporations department person with whom I spoke.
