Dear Mr. Toner,

I am in receipt of your above referenced letter. After further investigation, I think I have finally figured out where the problem of non-payment of the year 2000 fees filing fees has occurred. First of all, if you examine the Document # P98000103196 that was completed and filed on 1/10/00 by our previous administrator, please note that the document is addressed to "IMS Financial Group, Inc.", however the FEI Number is "59-3148956" which belongs to our other corporation titled "Investment Monitoring Services, Inc.". Although I cannot speak for our previous administrator, I don't think she noticed that the name of the corporation referenced, was not the name of the corporation that we currently conduct business under. This important detail also escaped me, as I was unaware that the name was an issue. We frequently use "IMS" as an abbreviated name for "Investment Monitoring Services", as we are one in the same. I now realize that they are totally separate corporations with different FEI numbers. Upon further research, I was unable to find any evidence that we ever received a Uniform Business Report from the Florida Department of State for "Investment Monitoring Services, Inc."

Enclosed please find our check for \$158.75, which should cover the year 2000 filing fee of \$61.25, \$88.75 for the corporate supplemental fee, and \$8.75 for a certificate of status. Had both UBR's for our two corporations ever been received, they would have both been processed and paid promptly, as the one we did receive was. It is my hope that the Florida Department of State would take all of this information into consideration, waive the reinstatement fee of \$600.00 and reinstate our corporation as soon as possible.
