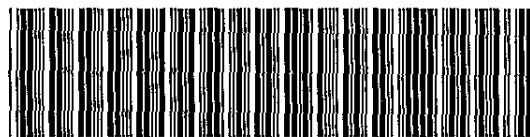


The company ceased operation in March of 2003. All bank accounts were closed that month and there were insufficient funds available to cover outstanding obligations. There are no assets.
