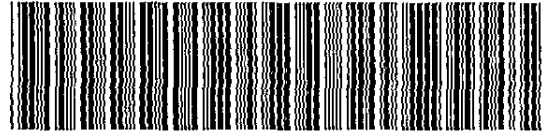

SECOND: The date of dissolution was authorized: December 27, 2005.


THIRD: The dissolution was approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.
