**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, **WASTECO, INC.**, a Florida corporation (the "Company"), hereby files the following Articles of Dissolution for the purpose of dissolving the Company:

1. The name of the Company is **WASTECO, INC.**
2. The filing date of the Articles of Organization was September 21, 1992, under Document No. V65384.
3. The dissolution was authorized and approved by the sole shareholder of the Company by written consent dated April 24th, 2017, which is sufficient for the approval of the dissolution of the Company.
4. The Company has paid or made reasonable provisions to pay all known claims and obligations of the Company, including all contingent, conditional, or unmatured claims known to the Company and all claims known to the Company but for which the identity of the claimant is unknown.
5. The Company has made distribution of all remaining property and assets to the sole shareholder.
5. There are no suits pending against the Company in any court.

In accordance with Section 607.1403 of the Florida Business Corporation Act, the dissolution of the Company shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
