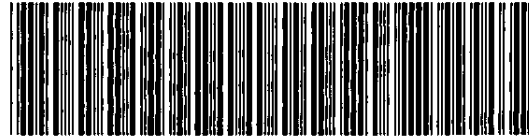


Dear Colleagues:
