ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PRECISION SHAPES, INC.



Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

FIRST: The name of the corporation is PRECISION SHAPES, INC. The Corporation Document Number is V69302.

SECOND: Amendments adopted:

"ARTICLE III
