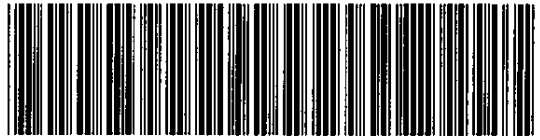

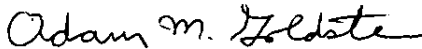

Pursuant to section 607.1403 of the Florida Statutes, we, the undersigned, being the duly appointed, qualified and acting President and Secretary of Royal Caribbean Merchandise Inc., a profit corporation organized under the Laws of the State of Florida on the 14th of October, 1992, with Document Number V70990 (the "Corporation"), hereby certify that:

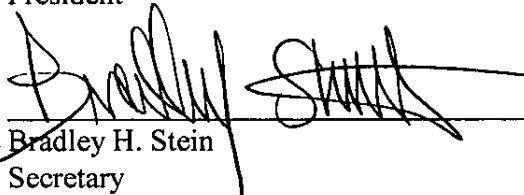
1. The name of the Corporation is ROYAL CARIBBEAN MERCHANDISE INC.
