AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ALBERT J. NEMETH, M.D., INC. 2022 JUL 12 AH 9: 04

Pursuant to the provisions of Florida Statutes Sections 607.1001;606:1002; 507.1006, 607.1007 and 607.071 of the Florida Business Corporation Act, these Amended and Restated Articles of Incorporation (these "Amended and Restated Articles of Incorporation") of ALBERT J. NEMETH, M.D., INC., a corporation duly organized and existing under the laws of the State of Florida as filed on October 16, 1992 and assigned document number V71793, the undersigned officer confirms that these Amended and Restated Articles of Incorporation were duly adopted by written consent of the sole shareholder and sole director on July 11, 2022. The number of votes cast for the amendment by the sole shareholder was sufficient for approval. These Amended and Restated Articles of Incorporation hereby amend and restate Articles of Incorporation and supersede and replace the provisions of the Corporation's original Articles of Incorporation in their entirety:

ARTICLE I. NAME

The name of the Corporation is ALBERT J. NEMETH, M.D., INC. (the "Corporation").

ARTICLE II. ADDRESS

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV. AUTHORIZED SHARES
