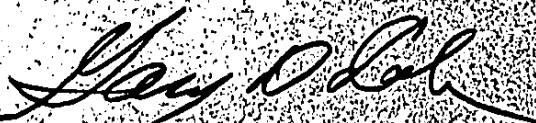
Please refer to the enclosed copy of a letter from Pamela Hall, Document Specialist and letter # 796A00045059.
