

As per our conversation, please accept this letter of explanation for our late Business Report filing and registration.

I, Mr. Martel, registered agent and corporate president have been incapacitated due to major surgery and therefore as primary filing agent have been unable to attend to completing this report. In May 1999, I underwent back surgery which was not successful which resulted in a temporary disability for some time and led to another back operation in December 1999 (7th operation). The last operation left me disabled until mid 2000. In the interim I closed the office at PGA Boulevard to defer expenses due to not being able to work in my prior capacity.

I have since re-opened an office in North Palm Beach and have attempted to get back to work on a part-time basis. An auto accident in March has further slowed this process.
