
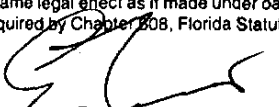

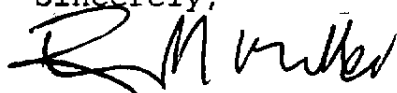
Dear Leslie:
