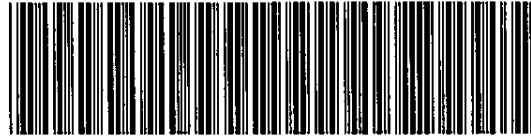

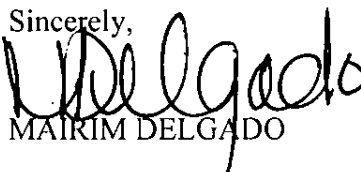

The effective date of the dissolution of the Company shall be the date of filing of these Articles of Dissolution.

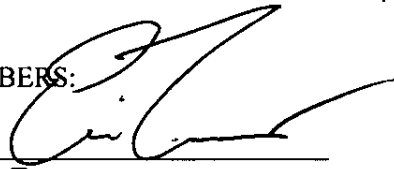
ARTICLE III - OCCURRENCE THAT RESULTED IN DISSOLUTION

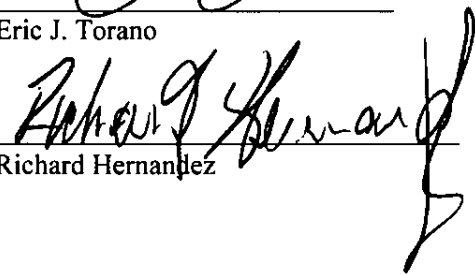
