This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a not-for-profit corporation under the laws of the state of Florida.

**ARTICLE I
NAME**

The name of the corporation will be B.T.C. PARENTS, INCORPORATED.

**ARTICLE II
PRINCIPAL OFFICE**

The principal office for transaction of the business of the corporation shall be located in the County of Broward, State of Florida. The initial business address of the corporation shall be 1100 N.W. 4th Street, Fort Lauderdale, Florida 33311.

**ARTICLE III
NATURE OF BUSINESS**

The general nature and purpose of this corporation shall be to enhance and promote the Christian growth and development of our children in the First Baptist Church Piney Grove, Black-Tunnage Junior Choir.

**ARTICLE IV
ELECTION OF BOARD OF DIRECTORS**

The business affairs of this Corporation shall be managed by the Board of Directors. The Corporation shall have five (5) Directors initially. The Corporation shall be comprised of at least five (5), but never more than seven (7) Directors elected by a majority vote of the members at their Annual meeting or at any special meeting held for that purpose. **ARTICLE VIII
POWERS**

Notwithstanding any of the powers given to this Corporation by the By-laws, these Articles, or by the State of Florida, the following limitations of powers and purposes shall apply and be paramount:

(a.) The Corporation is organized and shall be operated for the benefit of the children in the Black-Tunnage Junior Choir of First Baptist Church Piney Grove seeking to expand their Christian growth; and

(b.) The corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its members, directors, officers, or to any private individual; but the Corporation shall be authorized and empowered to make reimbursement for expenditures and pay reasonable compensation for services rendered and such payment shall not be deemed a distribution of net earnings under the paragraph.

**ARTICLE IX
TERM**

This Corporation shall have perpetual existence.

**ARTICLE X
MEMBERSHIP**

The membership shall consist of anyone interested in the enhancement of the children of the Black-Tunnage Junior Choir of First Baptist Church Piney Grove.

**ARTICLE XI
INITIAL REGISTERED AGENT AND OFFICE**

The initial registered agent is Karen E. Black-Barron and the initial registered office address is 3756 N.W. 37th Street, Lauderdale Lakes, Florida 33309.

**ARTICLE XII
AMENDMENTS**

The Articles of Incorporation may be amended by the Board of Directors with a required two-thirds (2/3) vote of all members, after the secretary has notified all members at least ten days before the meeting.

Amendments may also be made at a regular meeting of the membership as provided for in the By-laws by a majority vote of the quorum present.



DISSOLUTION

This Corporation may be dissolved by the Board of Directors with a required two-thirds (2/3) vote of all members, after the secretary has notified all membership in writing at least ten (10) days before the meeting. In the event of dissolution, the residual assets of this corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code or to the federal, state, or local government for exclusive public purposes. No part of the net earnings of this corporation shall inure to the benefit of any member of the corporation or any other private individual.


ARTICLE XIV

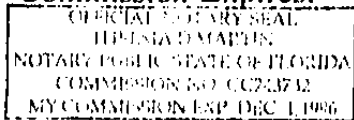
