The undersigned, as the president and secretary of RICHARD L. SHORT, D.O., P.A., does hereby certify that the Amendment provided for herein was adopted by the sole stockholder and sole director on the 22nd day of April, 1997.

1. Name of Corporation: RICHARD L. SHORT, D.O., P.A.

2.
